Until now polishing concrete required expensive grinding machines, dust vac systems & standalone generators to provide the power source along with highly skilled personal at a substantial cost per sq. ft.

Follow these simple steps using a standard floor machine for smaller areas.

For larger areas, it is recommended to use a walk behind scrubber with 100lbs of head pressure

Step One: Place four Dura Grit 4" 200 grit tools on a 20" floor scrubber using a red polyester pad. Apply clear water solution on the surface and proceed to make 8 to 10 passes & pick up the slurry
